Dogs and other animals:

- (a) Dogs are not allowed on the property at the following facilities owned by the City of Lenoir: Mulberry Recreation Center, Martin Luther King Jr. Recreation Center, William B. Stronach Jr. Lenoir Aquatic and Fitness Center, Mack Cook Stadium, Lenoir Rotary Soccer Complex, and West End Park. These facilities have athletic fields, picnic shelters, restroom/concession buildings and playgrounds where children participate.
- (b) Dogs are permitted at these facilities when approved classes are offered by the Parks and Recreation Department as well as K-9 classes and service animals. While in the class, dogs must be restrained by a leash not exceeding 6' in length and under the control of the owner at all times.
- (c) Owners are responsible for cleaning up after their dogs.
- (d) No other animals are permitted in these parks.
